## **UNACCEPTABLE STATEMENTS**

- THE THREE RECURRENT THEMES OF MAGISTERIUM ARE:  
**POVERTY, IMMIGRATION, ENVIRONMENT.**
- ALL ARE CONSEQUENCES OF THE REJECTION OF LIFE.  
**CONSEQUENCES, NOT CAUSES.**
  
- BUT WE HEAR ONLY TALK ABOUT MORAL **EFFECT**  
(CONSEQUENCES) AND NEVER ABOUT **CAUSES**, WHEN  
INSTEAD THE MORAL AUTHORITY SHOULD DO THE OPPOSITE.

**WHY DO WE CONFUSE CAUSES WITH EFFECTS?  
(IT IS THE MORAL MISERY THAT GENERATES ALL THE OTHER  
MISERIES).**

- IS IT NOT IN FACT **THE INEQUITY** THE ORIGIN OF ALL  
EVILS?, WHICH IS THE SIN, OF WHICH INEQUITY IS THE  
CONSEQUENCE. (IT IS NOT THE ECONOMY THAT KILLS...).

# INTRODUCTION

## THE REJECTION OF LIFE: A WANTED DEMOGRAPHIC CATASTROPHE FOR MANKIND

- THE REJECTION OF LIFE: IS REJECTION OF THE DIVINE GENESIS AND OUR CREATOR.  
IT IS THE REJECTION OF THE NATURAL LAWS: "**GO AND MULTIPLY**".
- THE DEMOGRAPHIC COLLAPSE **WAS PLANNED** TO GENERATE THE GLOBAL CATASTROPHE FOR MANKIND (ECONOMIC, GEOPOLITICAL, SOCIAL, POLITICAL, MORAL...).
- UNTHINKABLE THAT THE DECISION MAKERS DID NOT KNOW WHAT WOULD HAVE BEEN CREATED BY REFUSING LIFE...  
*... FROM THE ECONOMIC POINT OF VIEW:*

## THE IRREVERSIBLE ECONOMIC CATASTROPHE WAS THE FIRST CONSEQUENCE

- HOW CAN THE **GDP GROW** IF THE POPULATION DOES NOT GROW, OR DECREASES?
  - THANKS TO THE **CONSUMERISM!**

BUT THIS CAUSES SACRIFICE OF SAVINGS;  
WANTS DELOCALIZATION (OF PRODUCTIONS) TO REDUCE COSTS, WHICH PROVOKES **DE-INDUSTRIALIZATION**, COLLAPSE COMPETITIVENESS AND UNEMPLOYMENT.

- EXCESS OF CONSUMERISM IN THE WEST AND TOO FAST DELOCALIZATION IN THE EAST CAUSE THE SUPPOSED **ENVIROMENTAL PROBLEMS** (CO<sub>2</sub>) AND ENVIRONMENTAL AWARENESS.

- **COLLAPSE OF BIRTHS GENERATES AGING POPULATION**

(COSTS AND TAXES) AND THE PROSPECT OF FILLING THE GAP WITH IMMIGRATION.

- ALL THAT, TO SUBSTAIN GDP GROWTH, INCREASES THE DEBT UNSUSTAINABLE, UNTIL THE COLLAPSE (2007).

***... THE ECONOMY IS A FORMIDABLE MEANS OF PERSUASION FOR CHANGING THE WORLD, BECAUSE IT CREATES POVERTY, INEQUALITY, ETC..***

**THE GEOPOLITICAL CATASTROPHE WAS THE “GLOBAL CONSEQUENCE”**

THE **WORLD SPLITS IN TWO:**

- **THE WEST** (WITHOUT POPULATION GROWTH) THAT CONSUMES TOO MUCH AND DOES NOT PRODUCE ANYMORE.
- **THE EAST** (WITH POPULATION GROWTH) THAT PRODUCES AND STILL DOES NOT CONSUME.

THE WEST BECOMES POOR, THE EAST BECOMES POTENTIALLY RICH... NEW POWERS ARE CREATED, NEW INBALANCES, NEW RISKS..

- THAT JUSTIFIES THE **NECESSITY OF MIGRATION** (AIMED TO

CREATE THE WANTED RELIGIOUS SYNCRETISM OF KOFI ANNAN).

- THAT JUSTIFIES THE **NECESSITY TO PROTECT THE ENVIRONMENT (FROM THE MAN, CANCER OF NATURE)**, WITH ECONOMIC DECREASE AND FURTHER DEGROWTH OF POPULATION (COMPENSATED BY IMMIGRATION).

*... WITH SOCIAL CONSEQUENCES..*

## **THE SOCIAL CATASTROPHE WAS A NATURAL CONSEQUENCE**

**THE FORCED AGING OF THE POPULATION:**

- THE CHANGED SOCIAL STRUCTURE HAS CREATED A SERIES OF VERY **DANGEROUS “GAPS”:**

**(ECONOMIC, CULTURAL, RELIGIOUS...).**

- GENERATED THE NEEDS TO **REPLACE BIOETHICS** WITH BIOLAW (FROM THE WORLD HEALTH ORGANIZATION (OMS) TO MANAGE THE CYCLE OF BIRTHS AND DEATHS AND TO PREPARE THE “NEW CREATION” (EUTHANASIA, EUGENETICS, ARTIFICIAL INTELLIGENCE...).

**THE GREATEST ENEMY TO FIGHT WAS THE FAMILY (AND THE CHURCH, SEE BEYOND). THE NATURAL FAMILY HAD TO BE DISINTERMEDIATED BECAUSE THE FAMILY PROVIDES SUBJECTIVE EDUCATION, AUTONOMY AND INDEPENDENCE FROM THE STATE.**

... *BUT POLITICAL SUPPORT WAS NEEDED..*

**POLITICAL CATASTROPHE WAS PREDICTABLE, BECAUSE  
NECESSARY FOR IMPOSING A GLOBAL “POLITICAL  
VISION”**

- A GLOBAL POLITICAL VISION DOES NOT ALLOW COEXISTENCES WITH AUTONOMOUS **NATIONALISTIC GOVERNMENTS** AND FOR THAT, IT HAS DECREED THE END OF TRADITIONAL DEMOCRACIES AND OF NATIONAL SOVEREIGNTY.

- IT IS UNTHINKABLE THAT NATIONAL GOVERNMENTS **COULD REFUSE** THE IMPOSITION OF GLOBAL SOLUTION TO THE EMERGING PROBLEMS (ECONOMIC, IMMIGRATION, ENVIRONMENT, ETHICAL CIVIL LAWS...).

... *YES, BUT THE ROLE OF THE CHURCH?*

**MORAL CATASTROPHE IS IMPOSED, AT THIS POINT...**

- IT IS UNTHINKABLE THAT **ANY INTERFERENCE OF THE CHURCH** IN DEFENSE OF ETHICAL LAWS AGAINST THE NEW MORALITY, IMPOSED BY THE GLOBAL WORLD, THE UNITED NATIONS/WORLD HEALTH ORGANIZATION (ONU/OMS), WAS TOLERATED!

- **THE CHURCH WOULD HAVE COLLIDED OR ISOLATED (OR OPEN UP AND DIALOGUE...).**

- THE GLOBAL WORLD WANTS A RELIGION LIKE BUDDHISM, WANTS A VISION OF ECUMENICAL, RELATIVISTIC,

EVOLUTIONISTIC FAITH, **MORE FOCUSED ON ECONOMIC REALITY THAN ON THE DOGMAS.**

- I SUPPOSE THE DESIRED UNIVERSAL RELIGION, CURIOUSLY, IS THE **GNOSTIC ENVIRONMENTALISM** ON WHICH A RELIGIOUS BELIEF SHOULD CONVERGE (THANKS TO SYNCRETISM, PERHAPS THROUGH A SHORT PASSAGE TO LUTHERANISM?).

**DO NOT FORGET THAT THE THE NEW WORLD ORDER (N.W.O.) COINCIDES WITH VATICAN II**
